

ONLINE PRIVACY POLICY AGREEMENT

Why We Collect Information and For How Long

We are collecting your data for several reasons:

The length of time we retain said information will be determined based upon the following criteria: the length of time your personal information remains relevant; the length of time it is reasonable to keep records to demonstrate that we have fulfilled our duties and obligations; any limitation periods within which claims might be made; any retention periods prescribed by law or recommended by regulators, professional bodies or associations; the type of contract we have with you, the existence of your consent, and our legitimate interest in keeping such information as stated in this Policy.

NILSA'S ELEMENTAL ART. may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the services you need and request. At times, we may find it necessary to use personally identifiable information as a means to keep you informed of other possible products and/or services that may be available to you from www.nilsaselementalart.com and its subsidiaries.

Notice to European Union Users

NILSA'S ELEMENTAL ART.'s operations are located primarily in the United States. Security
